***EQUIPMENT, RENT AND TERMS OF RENTAL AGREEMENT:**

Delivery to address specified by lessee (customer). Lessee grants right to enter said property for the delivery and pick-up of equipment at approximately specified times.

***GENERAL RULES TO FOLLOW DURING USE OF THE UNIT:**

Lessee agrees to supervise both the equipment and its use at all times said equipment is in the possession of the lessee. I agree to follow the safety rules both on the unit and within this contract at all times during the operation and use of the interactive games and equipment. Only compatible age groups and size shall play on the unit at the same time. The maximum number of riders that shall play in the unit at one time is:

***Moonwalk:** Children 8 and under = 7, Children 9-12 = 5, Teens= 3-4, Adults = 2

***Slide:** Only one (1) person may slide down at a time. **NO MORE** than five (5) children or two (2) adults may be on unit at any time. **DO NOT** slide down any slide head first! Must slide feet first.

***Obstacle Course:** Two participants in each section at a time. All participants must travel same direction.

* All riders must remove shoes before playing in the unit.

* To avoid injury, flips are not allowed.

* Do not use the unit during rain. If unit becomes wet, thoroughly dry prior to allowing use.

* No objects other than the provided basketballs are allowed in any unit.

NO SILLY STRING!!!

Absolutely no gum, candy, food, drinks or other sticky or wet substances are allowed. If upon pick-up, such cleaning is required a \$50.00 cleaning fee shall be automatically imposed. Lessee also represents and warrants safe return of the unit and hereby agrees to the value of four thousand dollars (\$4,000).

I understand and acknowledge that the activity to be engaged in through my rental of an inflatable, interactive game(s), concession machine and games brings with them both known and unanticipated risks to my guests, my invitees and myself. Those risks include, but are not limited to falling, slipping, crashing and colliding and could result in injury, illness, disease, emotional distress, death and / or property damage to myself or my guests and invitees.

I voluntarily release, indemnify, hold harmless and discharge Jumpin Beans Party Rentals Inc. (Hereinafter collectively referred to as "JBPR"), from any and all liability, claims, demands, actions or rights of actions whether personal to me or to a third party which are related to, arise out of or are in any way connected with my rental of the interactive inflatable unit including those allegedly attributable to negligent acts or omissions. I agree to reimburse any reasonable attorney's fees and costs which may be incurred by JBPR in the defense of any such liability claim, demand, action or right of action.

In the event that I file a cause of action against JBPR, I agree to do so solely in Volusia County, Florida and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

I acknowledge that I have adequate homeowner's insurance, tenant insurance, or other liability insurance to cover any bodily injury or property damage which might occur to myself, my guests, or my invitees from the use of the unit(s) I am renting or else I agree to bear the costs of such injury or damage myself.

***RAIN POLICY: If you decide to accept delivery of the unit(s), there will be no refunds.**

In the event of strong winds, unit(s) must be deflated. This is the responsibility of the lessee.

I acknowledge and certify that I have had sufficient opportunity to read this entire document, that I understand its contents and that I execute it freely, intelligently and without duress of any kind and agree to be bound by its terms.
